The Company clarifies that, pursuant to art. 4, sole paragraph, of CVM Resolution No. 44, of August 23, 2021, questioned people with access to relevant acts or facts, in order to ascertain whether they would have been aware of information that should have been disclosed to the market, having confirmed that they are not aware of any information in this regard.

These being the considerations deemed pertinent regarding the Official Letter, the Company is available for further clarification that may be necessary, reinforcing its commitment to keep shareholders and the market in general informed about any matter of interest to its shareholders or the market.
